### 1. INTRODUCTION

**Purpose.** The purpose of this Privacy Policy is to describe how Safety With Accountability & Transparency LLC d/b/a/ SWAT (“Company”) collects, uses and shares information about you through our U.S. online interfaces (e.g., websites and mobile applications) owned and controlled by us, including [www.raheem.ai](http://www.raheem.ai) and the Facebook Messenger chatbot Raheem AI (collectively referred to herein as the “Site”). ### 2. INFORMATION THAT WE COLLECT

#### Information You Provide to Us

We collect information you provide to us, for example when you create or modify your account, register to use our Site, request information from us, contact customer support, or otherwise communicate with us. This information may include:

### **Information Collected Through Google Analytics**

### **Information Collected Through Cookies and Similar Technologies**

### **3. HOW WE USE AND SHARE YOUR INFORMATION**

**To Inform the Site Map.** We collect information from you in order to inform our digital map of all the reported interactions with law enforcement, and to provide information that you may request from us. We may send you promotional materials or advertisements about our products and services, as well as new features of the Site.

**Sharing with Third Parties.** We may provide information to third party service providers that help us operate and manage our Site. - Enforce applicable Terms of Use, including investigation of potential violations.
- Detect, prevent, or otherwise address fraud, security or technical issues.
- Protect against harm to the rights, property or safety of Company, our users, customers or the public as required or permitted by law.

**Transfer in the Event of Sale or Change of Control.** If the ownership of all or substantially all of our business changes or we otherwise transfer assets relating to our business or the Site to a third party, such as by merger, acquisition, bankruptcy proceeding or otherwise, we may transfer or sell your personal information to the new owner. In such a case, unless permitted otherwise by applicable law, your information would remain subject to the promises made in the applicable privacy policy unless you agree differently.
